Volunteers play a large role in programming at PHA. Heritage Culturalists provide bike and walking tours along the heritage area and share their knowledge of history and events. Other volunteers help with events and office work. In 2021, volunteers reporting donating 749 hours of volunteer work.

The Poudre Heritage Alliance (PHA) is the managing entity for the Cache la Poudre National Heritage Area. In 2021, PHA provided seven bus scholarships to transport 476 students on field trips within the heritage area through the Learning in Our Watershed program. PHA's community grant program disbursed \$52,652 in grant funds to support construction planning documents at the Poudre Learning Center and The Town of Windsor Museum Eaton House as well as support of the water documentary film, Watering the West. Additionally, PHA providing funding for the Hand that Feeds sculpture which is designed to preserve the history and contributions the Hispanic and Mexican people who played a critical role in Northern Colorado's sugar beet history.

PHA events for 2021 included the Poudre Pour and Pub Talks. The 4th Annual Poudre Pour had over 200 in attendance. The four Pub Talks hosted 55 participants and discussed agriculture irrigation and using water for brewing. PHA also supports community partner events including the Poudre Forum, Poudre River Fest, and children's water festivals to name a few.

In 2021, PHA continued working on a couple of special projects. The Water Legacy oral history documentation project was funded by the Colorado Water Conservation Board and will wrap up in 2022. Lifting Voices was funded by the National Parks Service and tells the story of indigenous women's right to vote and was completed in 2021. The strategic interpretive planning was funded by Colorado Parks and Wildlife and will continue into 2022. The Bellvue Lab continued to receive site improvements and maintenance for the safety of privately tours. This project is anticipated to be completed by the end of 2024 as a partnership with the landowner, the Jackson Ditch Company.
